JUNE 3, 2023

The 2023 Annual Meeting was called to order by the President, Mike O'Brien, at 0916, Saturday, 3 June 2023.

A warm welcome was given to our new neighbors, Averi and Raymond Murphy, 2 Pond Road.

Last years minutes have been posted on our website. A motion was made by Louanne Stephenson to accept the minutes. The motion was seconded by Norman Duval and passed.

The Treasurer's report was given by Ed Stephenson, see attached report. A motion was made by Louanne Stephenson to accept the minutes. The motion was seconded by Diane O'Brien and passed.

The President made his report to the membership. The main topic of discussion was unauthorized beach use. At one time, in 2007, beach passes were issued to the membership. The problem was no one wanted to sit at the beach entrance and check passes. That is the problem, no one wants to spend their day at the beach entrance and be the meanie that chases nonresidents away. The President emphasizes that this organization is run by volunteers. Therefore, we are always looking for help to complete different projects by ourselves; not by hiring professionals.

Dock Master Report; The dock slip list is being updated, as boats are being moved to different slips to accommodate the larger boats. The docks have been leveled, repaired and two docks were replaced, due to old age. At the moment, all the docks are in excellent condition.

Beach Master Report:

Beautification Committee Report;

Ed Stephenson gave a report of the Winnisquam Watershed Network. The WWN is an organization formed to protect and improve Lake Winnisquam. We are trying to organize the 886 homeowners on the Lake and the five towns that have lake front property. If we can get everybody together, then we will have a louder voice in Concord. The WWN is involved in three water testing programs, administrated by NH DES. The programs involve the testing of three deep locations, two offshore locations and the testing of the 12 tributaries that flow into Lake Winnisquam. The same locations are tested every year, on a monthly basis, during the summer and NH DES has a lot of the data from the sampling posted on their website. The WWN has received a \$ 109,000 grant from the EPA and NH DES to work on slowing down runoff from the roads and other locations into the lake. We will be working on three initial sites this summer.

Ed Stephenson gave a report on 2022 projects completed, 2023; 2024 and 2025 projects that need to be accomplished. See the attached sheets for more details.

The new trash cans being used by the town started a lengthy discussion. The SSIA has been approved to receive two new cans. The cans will cost \$ 150.00 each, with an annual charge of \$ 150.00 to pick up the trash/recycling. A motion was made by Denis Duval to contract with the town for two new trash cans to be placed at the beach and to sign up for yearly trash service at the beach. The motion was seconded by Sue Hjelm and passed. Ed Stephenson will coordinate the purchase with the town on Monday.

The annual elections were held.

Denis Duval nominated Beth Simpson to be Secretary. The motion was seconded by Diane O'Brien and passed.

No nominations were received for Vice President. A motion was made by Norman Duval to send an e-mail out to the

membership looking for a volunteer to be Vice President. The motion was seconded by Don Simpson and passed.

Ed Stephenson nominated Mike O'Brien for President. The motion was seconded by Denis Duval and passed.

Diane O'Brien nominated Ed Stephenson to be Treasurer. The motion was seconded by Denis Duval and passed.

Diane O'Brien made a motion to adjourn the meeting. The motion was seconded by Sue Hjelm and passed.

The meeting was adjourned at 1010 hours.
